#### **II TENURE OF ENGAGEMENT:**

The tenure of engagement shall be for a period of 15 years or the date of superannuation (60 years) whichever is earlier. However, the tenure of engagement beyond 15 years, shall be reviewed solely based on individual performance and project requirements.

#### **III UPPER AGE LIMIT AS ON 01.01.2025:**

Upper age limit is 50 years as on 01.01.2025. The upper age limit will be relaxable for SC/ST candidates by 5 years and for OBC (NCL) candidates by 3 years.

#### **IV EDUCATIONAL QUALIFICATION:**

Ex-servicemen retired/serving officers retiring shortly from Navy/ Air Force/ Army / Indian Coast Guard personnel with 3 years Diploma in Engineering or equivalent in Electronics/Electronics & Communication /Electronics & Telecommunication/ Communication/ Tele-communication/Electrical & Electronics/ Electrical discipline in the rank of JCO or equivalent having 15 years & above post qualification experience. Candidates should have secured PASS CLASS in the indicated qualification.



## V POST QUALIFICATION EXPERIENCE:

15 years or more relevant post qualification experience in working with various Electronics/Electrical Equipment's in Armed Forces(Navy/ Air Force/ Army / Indian Coast Guard) viz. Radars, Communication Radios systems, Weapon systems, Missile and Fire Control systems, Electronic Warfare systems etc. Candidate with experience in IT Hardware, networking and server/storage will be an added advantage.

## VI JOB DESCRIPTION:

Candidate will be responsible for installation/ commissioning and subsequent maintenance of Coastal Surveillance Systems (CSS) installed at different locations. Individual is required to travel to different project location on requirement basis.

The CSS equipment's are/ will be installed in various locations of Light House/ Coast guard premises. The CSS equipment includes surveillance Radar, Camera Systems, Communication system and other supporting Network and Power systems and necessary Server-Storage systems in Control center. The Engineer has to visit Light House/ Coast Guard locations for preventive and break down maintenance.

Candidate has to liaison with customer on day to day basis and monitor and maintain the CSS equipment installed at various stations.

## VII METHOD OF SELECTION:

Selection will be through written test followed by interview for candidates who have been shortlisted in the written test. The dates of the selections, timings and venue will be intimated to the shortlisted candidates through e-mail only.

### Enclosures to the application form:

- i) 10th Standard certificate (as proof of date of birth)
- ii) Diploma Engg. Certificate or equivalent in the indicated discipline.
- iii) Post qualification work experience certificate/s from previous / current employer.



iv) **For Ex- Servicemen (Navy/ Air Force/ Army / Indian Coast Guard) who are applying on re-employment basis:**

- Post qualification work experience certificate/s from previous / current employer if employed after retirement.
- Discharge certificate (Navy/ Air Force/ Army / Indian Coast Guard). The discharge certificate should clearly indicate the date of enrollment, date of discharge and rank at the time of leaving the defence forces
- Candidates presently working in Govt/PSU/Quasi-Govt organizations are required to produce a **No Objection Certificate** from their current employer.

v) **For Officers applying on immediate absorption basis:**

- No Objection Certificate to be produced indicating the probable date of discharge.
- vi) Candidates presently working in Govt/PSU/Quasi-Govt organizations are required to produce a No Objection Certificate from their current employer at the time of interview or forward their applications through proper channel.
- vii) Caste/Tribe/Community/Economic Weaker Section status Certificate in case of candidates belonging to SC/ST/OBC/EWS respectively. Candidates claiming reservation under any of the above categories are required to submit the certificate in the prescribed format. Candidates belonging to OBC category should produce community certificate in Annexure 'B' format as prescribed for applying for posts under Central Government issued on or after 01.01.2024 and for EWS Certificate issued for the year 2023-24.

**IX PAY PACKAGE:**

The selected candidates will be inducted in the minimum of the pay scale of Rs. 30,000 – 3%-1,20,000/-. In addition to basic pay other allowances like Dearness Allowance, HRA, 35% of basic pay as perks, PF, Group insurance, Performance Related Pay, Gratuity, medical facility for self and dependent family members, etc., as per Company rules will be a part of the pay package.
